### **What is the scope of processing my personal data by StethoMe<sup>®</sup>?**

StethoMe<sup>®</sup> provides you a newsletter service. To provide you our service we need your e-mail address.

### **What is the purpose of the processing my personal data by StethoMe<sup>®</sup>? What are the legal basis for such processing?**

We process your personal data in order to provide you with our newsletter service. The purpose of processing is to fulfil our obligations with newsletter service. We understand purposes of processing as:

#### **Purpose of the processing**

Via newsletter we provide you with all the latest information regarding our products, services. We provide you newsletter service by your consent. We also store your personal data.

#### **Legal basis for processing**

art. 6 para. 1a of the GDPR.

### **Is my data processed in any other way?**

We do not process your data in any other way.

### **Who are the recipients or categories of recipients of my personal data?**

The only recipient of your data is StethoMe sp. z o.o. To provide you with our service, we use Mailchimp (<http://mailchimp.com>). We concluded with Mailchimp data processing agreement which guarantees security of all personal data.

### **Will my data be transferred to third country or an international organization?**

Data transfers to units outside the EU may take place as long as it is necessary for the purpose of fulfilling contractual obligations. We declare that in a such case, we conclude an data processor agreements with our service providers, in compliance with GDPR.

### **For how long will my data be processed?**

We will process and store your personal data for as long as it is necessary in order to fulfill our contractual and statutory obligations. It should be noted here that our business relationship is a long term obligation, which is set up on the basis of periods of years. If the data is no longer required in order to fulfill contractual or statutory obligations, it is deleted, unless its further processing is required – for a limited time – for the purpose of fulfilling obligations to preserve records according to commercial and tax law.

### **Is providing my personal data my obligation?**

The use of our services is voluntary, however, we need your data in order to provide you our newsletter service. The lack of data may result in the inability to use our services and in principle we are not able to execute a contract with you.

### **What are my rights?**

As a controller of your personal data we provide you with the right to access your data anytime. You have also the right to:

- a) rectification of your data [art. 16 of the GDPR],
- b) erasure of your data [art. 17 of the GDPR],
- c) restrict processing [art. 18 of the GDPR],
- d) object [art. 21 of the GDPR],
- e) if applicable – to data portability [art. 20 of the GDPR],
- f) lodge a complaint with an appropriate data privacy regulatory authority,
- g) withdraw any consent given by you to process your data.

You can withdraw any consent granted to us for the processing of personal data at any time. Please note that withdrawal only applies to the future. Processing that was carried out before the withdrawal is not affected by it.

GDPR – Regulation [Eu] 2016/679 Of The European Parliament And Of The Council Of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing directive 95/46/ec [general data protection regulation].
